Legislative News

The FTC has issued its final rule under the Fair and Accurate Credit Transaction Act (FACTA) regarding free credit reports for consumers. This rule allows consumers to request a free credit report from the three nationwide consumer reporting agencies (CRA's), Equifax, Experian, and TransUnion. A free report will only be provided, upon request, once every twelve months. The CRA's are also required to establish a "centralized source", for consumers to submit their requests, with a dedicated Internet Web site, toll-free telephone number, and postal address. The rollout of the centralized source will occur in stages from west to east within a period of nine months beginning December 1st, 2004.

All federal offices will be closed June 11, 2004 in respect to former President Ronald Reagan. This closing will not affect our normal business but serves as a day of mourning for the passing of our 40th president.
